EXPLANATION TO THE PROPOSAL FOR A DECISION on the appointment of a new Member of the Supervisory Board

In accordance with the established profile of the Supervisory Board of the Company Meritus ulaganja d.d. (hereinafter: "Meritus ulaganja" and/or "Company") and the procedures for the appointment of members of the Supervisory Board, the Supervisory Board of the Company, at its meeting on May 12, 2023, adopted a proposal on the appointment of a new member of the Supervisory Board:

I. Mr. Philipp Rösler

Mr. Philipp Rösler is best known as the former German Minister for Economic Affairs and Vice-Chancellor in Angela Merkel's government, and who has been involved in the work of supervisory and management bodies of numerous companies during his professional career (including in companies that are predominantly based in Germany).

It follows from the foregoing that Mr. Rösler has significant international work experience, which he has gained primarily in international business entities listed on international stock exchanges, with the predominant business segment being in the core markets of the Mplus Group and is a member of the management and/or supervisory bodies of the aforementioned legal entities. The Supervisory Board of the Company is of the opinion that it is in the interest of the Company to appoint Mr. Philipp Rösler as a member of the Company's Supervisory Board, as he can significantly contribute to the further development and growth of the Mplus Group, as well as to the profile of the Supervisory Board of the Company with his knowledge and many years of experience. In view of the fact that Mr. Philipp Rösler does not maintain and has not maintained any relations between the Company and persons related to the Company, Mr. Philipp Rösler is proposed as an independent candidate for the Supervisory Board of Meritus Investments d.d.

In addition, the Company stipulates that the minimum time commitment of Mr. Philipp Rösler as a member of the Supervisory Board of the Company will be in accordance with the work schedule adopted annually by the Supervisory Board, so that he is available and able to attend the meetings of the Supervisory Board, as well as on the days immediately preceding the meetings in order to study the documents relating to the agenda items on which the members of the board decide on at the meetings, all so that he can perform his duties as a member of the Supervisory Board correctly and efficiently.
